3. Commercial and Economic News:

INDIA - VENEZUELA

Ambassador of India to Venezuela meets Governor of Lara State: On 15 May 2021, Ambassador of India to Venezuela, Shri Abhishek Singh met with Governor of Lara State, Adolfo Pereira, to review the commercial and trade potentialities between India and Lara State. In addition, they discussed the scope for cultural and tourism activities. Read more.

OTHER NEWS

Venezuela's oil exports hover around 700,000 bpd: Venezuela's oil exports stood around 700,000 bpd. Of that 700,000 bpd, roughly 75% of that oil found its way to Asia and the Middle East. Venezuela's oil exports were below 400,000 bpd last September and below 370,000 bpd last October. But in November, Venezuela increased its exports to 690,000 bpd after it found new buyers that were all registered in Russia. Reports indicate that India, for one, is struggling to find more sources for cheap crude oil, has voiced its preference for being able import to Venezuelan oil. Read more.

Private equity funds eye Venezuela acquisitions: At least two private equity funds are seeking to acquire stakes in Venezuelan companies that have survived the country's economic crisis. The interest by funds, including Miami-based 3B1 Guacamaya Fund and Cayman Islands-based Knossos Asset Management. The renewed investor interest in the country due to possible sanctions relief has not been previously reported. Read more.

PDVSA aims to restart natural gas projects with private investment: PDVSA is mulling to reactivate the natural gas projects. For the purpose, the company would need around

US\$ 9.70 billion. PDVSA is reportedly seeking to obtain financing from national and foreign private companies. Reports indicate that the plan considers the reactivation of 14 gas fields in the country using licenses for participation of private players. Read more.

Venezuela's economic activity grew by 18.9% in first quarter: According to the Venezuelan Observatory of Finances, the country's economic activity grew by 18.9% in comparison with the last quarter of 2020. However, a drop of 33.7% was registered in inter-annual terms. The study indicates that the financial sector of Venezuela contracted by 22.5% during the first quarter of 2021 compared to the same period of 2020. Read more.

Conviasa inaugurated the Caracas-Moscow route: Venezuela's national air Carrier, Conviasa, announced on 03 May 2021, the inauguration of the first flight between Caracas and Moscow. The route is part of the agreements reached between Russian and Venezuela on their last joint commission. The direct flight would be operating on a fortnightly basis. Read more.

Certification of EpiVacCorona in Venezuela is expected: The Russian

Ambassador to Caracas Sergei Melik-Bagdasarov told media that Russia hopes that EpiVacCorona vaccine against the coronavirus infection is registered Venezuela soon. Speaking about purchases of the vaccine, the Ambassador noted that as soon as it is certified "all necessary opportunities will become open. A prospective manufacturer of EpiVacCorona, Russia's Geropharm company which is well-known to Venezuelans for its supplies of high-quality domestic insulin, is in close working contact Venezuelan with relevant agencies responsible for inoculation of residents," the diplomat explained. First 50 freezers for COVID-19 vaccines arrived in Venezuela: The United Nations Children's Fund said on 05 may 2021, that 50 freezer kits had arrived in Venezuela to boost the country's capacity to store coronavirus vaccines. The refrigerators, which have a 256-liter capacity, can hold some 8,500 vaccine doses and will be handed over to authorities for distribution to 100 hospitals in the country. Read more.

Venezuela to hold clinical trials of Cuban vaccine Abdala: Venezuelan authorities confirmed on 03 May 2021, that clinical trials of Cuban vaccine candidate Abdala would begin in May as the country advances in its immunization campaign. "We will be starting a clinical study with this vaccine, but simultaneously, adapting our national vaccine laboratory to produce, if all goes well as we hope, doses for four million people," Health Minister Carlos Alvarado said on national television. Single-dose Sputnik Light vaccine approved for use in Venezuela: The Russian Direct Investment Fund (RDIF, Russia's sovereign wealth fund) announced

the approval of the Russian single-dose Sputnik Light vaccine against coronavirus by the Ministry of Health of Venezuela. In January 2021, the two-dose Sputnik V vaccine was also approved for use in Venezuela under the emergency use authorization procedure. Read more.

Only 30% of the gas stations are operative in Venezuela: Around 536 out of 1,786 gas stations are operative in Venezuela. Reports indicate that under 600 stations are receiving constant supply of gasoline and only less than 1% of them receives permanent supply. Read more.

Venezuela scrambling to load oil ahead of China tax: Venezuela's state-owned PDVSA is scrambling to load crude cargoes before China imposes a new import tax that has blindsided management in Caracas. Most of the Venezuela's crude oil exports wind up in China's Shandong province, where independent refiners are girding for a new US\$ 30/bl tax on diluted bitumen, the product category under which Venezuela's 16°API Merey blend is imported after quietly transthrough Malaysia and shipping intermediate destinations to mitigate the risk of US sanctions. The tax takes effect on 12 June, and PDVSA is hoping loadings before 11 June will be clear of the new levy. In the meantime, it is hoping Beijing will reconsider the measure. Read more.

First diesel cargo in six months arrives in Venezuela: Venezuela's first diesel imports since November 2020, arrived during the week of 27 May 2021, aboard the tanker Bueno, carrying almost 500,000 barrels of diesel. It was not immediately clear who provided the fuel. Venezuela in recent years has become reliant on imported gasoline and diesel to compensate for state-run oil firm

PDVSA's insufficient domestic production. After Venezuela's main diesel supplier, India's Reliance Industries, suspended shipments in 2020 at U.S. request, some experts and nongovernment organizations have asked Washington to allow exceptions for diesel provision to secure medicine and food distribution and power generation. of the shipment. Read more.

1.3 million COVID-19 China sends vaccines to Venezuela: On 23 May 2021, President Nicolas Maduro announced the arrival of 1.3 million COVID-19 vaccines from China. Maduro pointed out that his government hopes to vaccinate 70% of the country's population in the upcoming months and reach the complete vaccination of Venezuelans by the end of this year. Read more.

Zara, Pull&Bear, Bershka to close stores in Venezuela as Inditex brand exits: Zara, along with Pull&Bear and Bershka, are owned by Spain's Inditex SA and have been operating as franchises in Venezuela since 2007. The franchise operator of Zara and two other popular apparel chains will close all of its stores in Venezuela in the next few weeks. Read more.

President of Venezuela hails Special Economic Zone 'Opportunities': President Nicolas Maduro praised the upcoming Organic Law of Special Economic Zones (SEZ) as an opportunity to boost national production with local and foreign investment. The President explained that the legislation aims to create new sources of foreign income beyond dependence on oil exports. The law contains five chapters and 26 articles. The President added that special economic zones are a successful formula applied in some of the world's fastest-growing economies such

as China, Vietnam, Singapore and South Korea. Read more.

Venezuela restarted crude blending after gas supply outage: PDVSA has restarted crude blending at its Sinovensa and Petropiar plants after a gas supply outage to the Jose oil export terminal halted operations earlier in May. The resumption comes as a very large crude carrier (VLCC) set sail after delays loading at Jose and a second VLCC prepared to leave, partly alleviating a bottleneck of vessels that had built up due to the gas outage, low inventories and quality issues.
