**Important India related statements of commercial significance by political leaders, think tanks, chambers, associations etc./ Significant stories/features on India related trade, investment, services and logistic sector, published in foreign journals/ dailies etc (Max 500 words)**

In August 2025, India's growing commercial footprint in Venezuela was spotlighted through diplomatic statements, trade chamber endorsements, and regional media coverage. A key moment came during the India–Latin America Investment Roundtable hosted in São Paulo, where Vice Minister Tatiana Pugh Moreno of Venezuela's Ministry of Foreign Affairs praised India's pharmaceutical and machinery sectors as "pillars of affordable industrial transformation." She called for deeper bilateral engagement, particularly in healthcare manufacturing and agro-processing.

The Venezuelan Chamber of Commerce and Industry (CAVECOM) issued a formal statement supporting India's role in diversifying Venezuela's import base. It highlighted the success of the Buyer-Seller Meet (BSM) on pharmaceuticals held in Caracas in July, noting that follow-up negotiations were underway with Indian firms for joint ventures in generic drug production. CAVECOM also urged regulatory harmonization to facilitate smoother entry of Indian goods. Think tanks such as the Latin American Institute for Strategic Trade (ILCES) published commentary on India's logistics capabilities, citing its cold-chain infrastructure and digital customs platforms as models for Venezuela's port modernization. A feature in EI Universal titled "India's Trade Diplomacy: A Model for South-South Resilience" praised India's proactive embassy-led outreach and sectoral missions, particularly in pharmaceuticals, textiles, and renewable energy.

In the services sector, the Federation of Indian Export Organizations (FIEO) and Venezuela's National Association of Software and IT Professionals announced a pilot initiative for remote service delivery and fintech integration. The program aims to connect Indian IT firms with Venezuelan SMEs seeking digital transformation, with support from both governments.

Finally, the Embassy of India in Caracas was commended in Correo del Orinoco for its role in facilitating trade dialogues and promoting institutional cooperation. The article emphasized India's balanced approach to commercial diplomacy, noting its alignment with Venezuela's development priorities and its commitment to equitable trade under the G77 and NAM frameworks.

**1. India–Venezuela Strategic Energy & Trade Cooperation**

In August 2025, India and Venezuela advanced their strategic dialogue in energy and trade through targeted institutional engagement. A technical delegation from India's Ministry of Petroleum and Natural Gas held consultations with officials from PDVSA, Venezuela's state oil company, to explore joint ventures in modular refining and upstream exploration. Venezuela expressed interest in adopting Indian technologies for low-cost refining and solar electrification in remote regions, aligning with its national energy diversification goals.

On the trade front, both countries reviewed progress on bilateral facilitation mechanisms, with emphasis on reducing non-tariff barriers and improving customs coordination. The Embassy of India in Caracas facilitated meetings between Indian exporters and Venezuelan regulatory bodies, focusing on pharmaceuticals, auto components, and agro-processing machinery. Discussions included proposals for a bilateral logistics corridor leveraging Indian cold-chain expertise and digital customs platforms.

Additionally, the Venezuelan Chamber of Commerce and Industry issued a statement supporting India's expanding role in Venezuela's industrial modernization, citing Indian machinery and ICT services as key enablers. Both sides reaffirmed their commitment to multilateral cooperation under NAM, G77, and South-South frameworks, positioning India and Venezuela as strategic partners in equitable development and resilient supply chains.
