In June 2025, India and Venezuela continued to deepen their commercial engagement through targeted sectoral cooperation, strategic dialogue, and institutional outreach. These developments reflect a shared commitment to expanding bilateral trade and investment beyond hydrocarbons, with a particular focus on textiles, digital infrastructure, and multilateral trade frameworks.

On June 18, 2025, the Embassy of India in Caracas hosted a bilateral trade promotion event

focused on the textile and readymade garments sector. Ambassador P.K. Ashok Babu addressed senior Venezuelan officials, including Vice-Minister Hendrick José Perdomo Colmenares, and representatives from chambers of commerce and textile companies. He highlighted India's global leadership in cotton yarn and home textiles, noting that Indian exports to Venezuela in this sector had nearly doubled over four years from USD 9.95 million in 2020 to USD 18.69 million in 2024. Cotton yarn exports alone grew by over 400%, while readymade garments saw a fourfold increase. Despite this growth, India's market share in Venezuela remains under 1%, indicating significant untapped potential. The event featured presentations from Texprocil and AEPC, and emphasized India's commitment to quality control and export compliance.

Separately, Venezuelan Minister of Foreign Trade Coromoto Godoy met with Indian Ambassador Ashok Babu and Bancoex President Guillermo Lara to review progress on bilateral commercial agreements. The meeting reaffirmed both countries' interest in accelerating the creation of a multilateral trade system and strengthening institutional mechanisms for cooperation. This dialogue builds on earlier agreements signed in February 2025, including an MoU on digital transformation in public services, health, and education.

India's services sector also demonstrated strong performance in June 2025, with exports rising 12% year-on-year to USD 32.11 billion, according to the Reserve Bank of India. Imports grew by 5%, driven by demand for foreign professional and technical services. These figures underscore India's continued strength in IT, business, and financial services—sectors that offer potential for collaboration with Venezuela, particularly in digital governance and e-health platforms. Both governments reiterated their commitment to South—South cooperation and inclusive development. Venezuela continues to view India as a strategic partner in technology-driven modernization, while India maintains its non-interventionist approach and supports Venezuela's
