The eligibility criteria, scope of work and terms and conditions for packing, transportation and forwarding of personal effects by air-freight to Shri Balagopalan K Nair, Flat No.1511, J-Block 1st Avenue, Gaur City – 1, Greater Noida West, Uttar Pradesh – 201301, India on a door-to-door basis will be as follows: -

A. Eligibility Criteria: The bidder should furnish the following along with the documents:

- (i) The agency needs to use its own packing materials, professional workers and transport.
- (ii) The bidding firm should be a registered firm/entity legally authorized or competent to engage in the business of packing, moving and forwarding operations in Venezuela for at least the last five years;
- (iii) Firms should possess experience of at least 5 years of executing contracts for packing and transportation of personal effects of officials in other Diplomatic Missions in Caracas and other places.
- (iv) The bidding firm should have either own vehicles or a formal agreement with the registered & reputed transport companies/firms for the provision of transport services and vehicles possessing fitness certificates for plying on roads;
- (v) The firm should have its registered office in Caracas and should have a self-owned or leased warehouse near Sea Port and the facility should be clean, dry and equipped with proper security with adequate insurance against fire, theft, etc, and
- (vi) The number of working staff used for packing and movement of goods on regular payroll of the firms should be at least 5 (five);

B. Scope of Work:

- (i) Packing and transportation from residence to the port of origin in Caracas (Venezuela) to Balagopalan K. Nair, Flat No.1511, J-Block 1st Avenue, Gaur City – 1, Greater Noida West, Uttar Pradesh – 201301, India on the basis of door-to-door of personal effects;
- (ii) Customs formalities at the port of origin & port of destination;
- (iii) All formalities relating to handling of consignment for surface from Caracas (Venezuela) on door-to-door basis;
- (iv) Arrangement of insurance as per prescribed procedures and facilitation in case of any claim on account of damage; Premium of Assured value of Rs.2,62,500/-

C. Specific Terms and Conditions:

D. Material to be shipped: May include personal effects (some of which may be fragile in nature and require special care) as per an indicative list given below:

- (i) Furniture, electronic appliances and fixtures;
- (ii) Kitchenware and foodstuff;
- (iii) Clothing, linen and shoes;
- (iv) Books and toys; and
- (v) Personal sports goods, if any
- (vi) Other Miscellaneous items of household use.
